**Public Speakers**

Before taking action on each item and during the general public comment period, the Chair will invite any interested in giving public comment to be recognized and come forward. Comments from the public on agenda items will be heard only when that item is being considered and are limited to 2 minute. Comments from the public on other matters, not appearing on the agenda but within the Board's subject matter jurisdiction, will be heard during the General Public Comment period and shall be limited to 2 minutes. Total public comment for each meeting is limited to 5 minutes per speaker. (Time estimates are only approximations as times will vary depending on duration of public comment, board member discussion, and other factors).
